## Planning application for Cromarty Hydrogen Project under Section 32 of the Town and Country Planning (Scotland) Act 1997

Dear

Please find enclosed an application for planning permission under Section 32 of the Town and Country Planning (Scotland) Act 1997 for erection of a hydrogen production and storage facility (Class 3: Business & General Industry, Storage and Distribution), road haul tanker loading facility, underground electricity connection, import substation, improvements to existing access road, site offices, parking, gatehouse and perimeter fencing, temporary construction and laydown area and ancillary development (the 'Proposed Development') at land to the east of the Beinn Tharsuinn Windfarm (NGR NH 64225 81469), falling within The Highland Council local authority area.

ScottishPower Energy Retail Limited ('SPERL') ('the Applicant') and Storegga Hydrogen Limited ('Storegga') are joint development partners for the Proposed Development. It will be powered by 100% renewable energy provided by ScottishPower Renewables either from the co-located onshore wind generation at Beinn Tharsuinn or through power purchase agreements with off-site renewable generation. The application site is privately owned and covers an area of approximately 11.9 ha and an indicative floorspace of 3616 m<sup>2</sup>.

RSK is acting as the agent and lead consultant for this application and herby submits this application to The Highland Council on behalf of the Applicant.

In addition, notice has been given to the landowner for the site on 31 October 2023.
